There were no sewer connection requests to be considered.

The monthly financial reports were reviewed.

Mr. Hovermale reviewed the history on the PSD's Rule 19A rate case that was filed with the PSC on November 19, 2010. The PSC staff came out with their recommendation of no rate increase in early March. The PSD filed on April 11 a Notice of Rate Increase, a proposed tariff, and financial justification for the proposed tariff. The tariff included a 3.2% rate increase and a \$0.43 per thousand gallon surcharge that would generate enough revenue within two years to get the PSD current on bond and reserve account payments. The PSC's Administrative Law Judge has set May 29 as the deadline to receive written direct testimony, with a hearing scheduled for June 15.

The FY2012 operating budget in the amount of \$1,146,420 as submitted by Mr. Hovermale was discussed. The total is about \$11,000 less than the previous year, but includes a 3% pay increase for the first time since the FY2009 budget. Mr. Jenkins felt it was not appropriate to approve a pay increase at the same time that the PSD's bond reserve accounts remain underfunded and unbudgeted. There was no motion to approve a budget, so a special meeting was tentatively scheduled for Wednesday, May 25, 2011, at 3:30 pm to adopt a budget.

Mr. Hovermale reported that he had met with Lee Fowler with the Morgan County Health Department about grease traps for commercial establishments like restaurants. Mr. Fowler had promised to make sure that a grease trap inspection would become a part of the restaurant health inspection.

The meeting was adjourned at 4:55 p.m. upon a motion by Mr. Jenkins.
