# Morgan County Commission Meeting Minutes January 4, 2010

#### **ADMINISTRATION ITEMS:**

### **Elect President for County Commission**

Commissioner Dugan stated that she thinks Commissioner Hutchinson has worked very hard as Commission President and has done a very good job. Commissioner Dugan stated that she nominates Commissioner Hutchinson to be president. On a Stacy Dugan/Thomas Swaim motion, the County Commission elects Brenda J.
