## Morgan County Commission Meeting Minutes January 3, 2011

The meeting was opened by Debra Kesecker, County Clerk at 9:30 a.m.

### **Elect President of County Commission**

Commission President, Brenda Hutchinson, approached the Commission and explained that two years ago, she was nominated as President of the County Commission. Commissioner Hutchinson stated that during the two years she has served as President, the Commission has sold War Memorial Hospital, which will help the county economically, enrolled in a purchase card program from which the county receives money back for using the card and has received over \$12,000 to date. Commissioner Hutchinson stated that over the past two years, the Commission has balanced the budget and has not had to raise the levy rate or lay off any county employees. Commissioner Hutchinson stated that she believes the presidency should be rotated and asked for nominations. Commissioner Close nominated Commissioner Dugan. On a Brad Close/Stacy Dugan motion, the County Commission nominates Commissioner Stacy Dugan to serve as Commission President for the year of 2011. This motion carried.

#### Holiday Schedule

Commissioner Dugan presented the 2011 Holiday Schedule for the Commission to review. On a Brad Close/Brenda Hutchinson motion, the Commission approved the holiday schedule for 2011. This motion carried.

#### Meeting Schedule

Commissioner Dugan presented the Commission Meeting Schedule for 2011 for the Commission to review. The Commission reviewed the schedule. Commissioner Hutchinson stated that she is not in agreement with the meeting schedule and stated that the meetings are scheduled every other week instead of weekly. Commissioner Hutchinson stated that being a County Commissioner is a full time job, and she feels that weekly meetings are needed. Commissioner Hutchinson requested that the Commission

Commissioner Close stated that he agrees being a County Commissioner is a full time job, but he doesn't feel weekly meetings are necessary. Commissioner Close stated that having meetings twice a month allows time for the Commissioners to be out working with the citizens. Commissioner Hutchinson suggested having the meetings begin at 9:30 am. The Commission agreed.
