## **Administration Items:**

# Dave Michael, Director, Morgan County WV Office of Homeland Security & Emergency Management & Zachary Caldwell, 911 Director- Update on 911 Emergency Center

Dave Michael and Zachary Caldwell approached the Commission to give an update on the 911 Emergency Center. Mr. Caldwell explained that the dispatchers have completed the mandatory training. Mr. Caldwell stated that they will be performing job interviews to hire 911 dispatchers. Mr. Michael and Mr. Caldwell will follow up and give another update at the April 4 County Commission meeting.

#### Morgan County Marcellus Shale Committee- Report on Marcellus Shale

Larry Schultz, Tim Seims and Jim Hoyt, all members of the Marcellus Shale Committee, approached the Commission to give a report on the preliminary report of the Morgan County Marcellus Shale Committee. The Morgan County Commission formed a committee in September 2011 to study the current Marcellus Shale boom and make recommendations to the Commission. Mr. Schultz, Mr. Seims and

Mr. Hoyt reviewed the report with the Commission and made a few recommendations. The County Commission thanked the members for their time and work on the report.

# John Stump, Steptoe & Johnson- Final reading of an Ordinance of the County Commission titled as follows: AN ORDINANCE AUTHORIZING THE PAYMENT OF THE LEASE REVENUE BONDS

John Stump, Steptoe & Johnson, approached the Commission for a public hearing and the 2<sup>nd</sup> and final reading of the ordinance authorizing the payment of the lease revenue bonds. There were no comments or questions from the public. On a Bob Ford/Stacy Dugan motion, the County Commission enacted the ordinance as presented on the 2<sup>nd</sup> reading. President Close voted yea, Commissioner Dugan voted yea and Commissioner Ford voted yea. Motion carried. The County Commission scheduled a closing date of March 25 for the refinance of the courthouse loan.

John Allen Swaim & Lewis Braithwaite- Deford Masonic Lodge Tax Purposes John Allen Swaim, Trustee & Lewis Braithwaite, Treasurer, Deford Lodge, approached the Commission and asked why other organizations in the county are tax exempt and the Deford Lodge is not. President Close explained that this is a tax classification issue and unfortunately the Commission cannot solve the problem. The Commission suggested Mr. Swaim and Mr. Braithwaite talk to the Assessor regarding their question.

#### The Honorable Debra Kesecker, County Clerk- Election Fund Request

The Honorable Debra Kesecker, County Clerk had previously presented the Commission with a estimate of cost in the amount of \$29,567.92 for the Special Levy Election for the Morgan County Board of Education. Ms. Kesecker explained that she is requesting an additional \$599 for the election budget. On a Bob Ford/Stacy Dugan motion, the County Commission approved the additional funds of \$599. President Close voted yea, Commissioner Dugan voted yea and Commissioner Ford voted yea. Motion carried.

# Bill Lewis & Robert Mangold, Morgan County Sheriff's Deputy Reserves- Funds request to replace diving gear

Bill Lewis & Robert Mangold, Morgan County Sheriff's Deputy Reserves, approached the Commission regarding funds to replace diving gear. Mr. Mangold is a diving specialist and lost his gear in his cruiser when it caught fire. Mr. Lewis and Mr. Mangold explained that they have already replaced all but 2 items and asked for the re-imbursement of \$500 for the insurance deductible. The Commission will further discuss the request during the budget meeting.
