Morgan County Parks and Recreation RFP for Mowing Services to County Parks

Morgan County Parks and Recreation is accepting bids for mowing of county owned parks commencing April 1, 2014 and ending October 31, 2014. Maintenance is to include mowing and trimming of grassy areas as designated below.

Rt. 522 Ballfield Complex (16 acre) twice weekly April-June, once weekly July-October, mow under the bleachers and spray underneath the fences.

Spruce Pine Hollow (3 acres) once every other week April-October

North Berkeley Park (1.93 acres) once weekly April-October, mow outside the fence on both sides of the stream

Biser Street- once weekly-April-October

Harmison Field- (2 acres) once weekly April-October, mow outside the fence and spray down the hill

Sealed bids will be accepted at 77 Fairfax Street, Rm 101, Berkeley Springs, WV- Attention: Jody McClintock, County Administrator.

Submissions must be received by 9 am on 3/19/2014. All Contractors must be licensed and insured. All questions must be submitted in written form to jmmclintock@morgancountywv.gov. Answers will be posted to the county website by 5 pm on 3/18/2014. Bids will be opened 3/20/2014 at 10:00 am in the County Commission Meeting Room.

Morgan County Parks and Recreation reserves the right to accept or deny any and all bids.

Questions:

Are we responsible for trash & limb removal and disposal at any or all of these sites?-Debris removal will be minimal.

For proposal purposes, how do you bill and pay? - We would expect to be invoiced. Checks are generally issued on the first and third Thursday of the month. Invoices must be received on Monday of those weeks by noon in order for a check to be issued that Thursday.

Is there a scheduled time that the Ballparks need to be completed or days to have that work done-Work at the ballfield would need to be done Monday-Friday before 3pm.

Will bidders be notified of the results of the bids and or pricing and do we have to be present at the bid opening-We do not require bidders to be present at the meeting. We do respond to each bidder via mail.
