Notice is hereby given that sealed Bids will be received by the commissioners of Morgan County, 77 Fairfax Street, Room 101, Berkeley Springs, West Virginia 25411 for:

Work under this Contract includes the demolition of the existing sidewalk and concrete steps, installation of new steps, sidewalk and drainage. Work includes areas around Green Street and along Route 9 in Berkeley Springs, WV.

A Pre-Bid Meeting has been scheduled for Wednesday, October 29, 2014 at 10am in the County Commission meeting room located at 77 Fairfax St., Berkeley Springs, West Virginia 25411. A Project site visit will follow this Pre-Bid Meeting. Attendance at the Pre-Bid Meeting is not mandatory for Bid qualification.

SEALED BIDS for the above will be received by the Commissioners of Morgan County, 77 Fairfax Street, Room 101, Berkeley Springs, West Virginia 25411, ATTN: Bath Community Center Project, in the County Commission office until 12:00 pm, Wednesday, November 19, 2014. Four copies of the bid should be submitted. Bids will be opened in the November 20, 2014 Morgan County Commission meeting at 10:00am.

Bids must be made upon the blank Bid Documents which, with the Bid Documents, Plans, and Specifications, will be furnished by the Morgan County Commissioners upon application and payment of \$100.00 per set. NO REFUND FOR RETURN OF DRAWINGS AND SPECIFICATIONS. No bids will be considered unless accompanied by a certified check, cashier's check, or a treasurer's check drawn upon a bank or a satisfactory Bid Bond furnished by a solvent surety company authorized to do business in the State of West Virginia payable to the Board of County Commissioners of Morgan County, West Virginia in the amount of Five Percent (5%) of the total bid price.

In addition, the successful Bidder will be required to furnish a Payment Bond and also a Performance Bond in the full amount of the Contract Award. The successful Bidder will be required to give Bond and comply with the laws of West Virginia respecting contracts.

All Prime Contractors and SubContractors shall be licensed in compliance with SB409 (WV Contractor's Licensing Act). All General Contractors shall include their license number in the space provided on the Bid Form.

After the scheduled closing time for receipt of Bids, no Bid may be withdrawn for a period of forty-five (45) days.

The Board of Morgan County Commissioners reserves the right to accept or reject any and/or all Bids and to waive any informalities or irregularities in the bidding.
