Commissioner Clark made a motion to come out of executive session at 12:57 p.m. President Forney voted yea, Commissioner Tuttle voted yea and Commissioner Clark voted yea. Motion carried.

Commissioner Tuttle made a motion the change ETC 911 starting pay to \$15 an hour. President Forney voted yea, Commissioner Tuttle voted yea and Commissioner Clark voted yea. Motion carried.

Commissioner Tuttle made a motion to give ETC 911 hourly personal a 75 cent raise per hour. President Forney voted yea, Commissioner Tuttle voted yea and Commissioner Clark voted yea. Motion carried.

Commissioner Tuttle made a motion to raise Ronald Mason yearly salary to \$48,000 and to raise Marshall Younker yearly salary to \$41,600 per budget request. President Forney voted yea, Commissioner Tuttle voted yea and Commissioner Clark voted yea. Motion carried.

Commissioner Tuttle made a motion to raise the stating salary for the Sheriff's Deputies to \$38,000 for non-certified and \$40,000 for certified. President Forney voted yea, Commissioner Tuttle voted yea and Commission Clark voted yea. Motion carried.
