John Peterson - Morgan County Emergency Communication Network

John Peterson presented the Commission with an update on improvements made to the Cacapon Tower and requested the exact geographic location to confirm the geographic area. He also discussed his plan to give a sophisticated and extensive public presentation covering emergency communication preparedness. During the presentation he wants to

give radios to each family in attendance, a "Go Bag" containing a map with rally points, a preparation and execution checklist, and emergency candles. He requested \$5,000 for the radios and \$17,000 for a backup generator. President Forney thanked Mr. Peterson for his presentation. Commissioner Tuttle would like to discuss redundancy issues with Jason Hoover before deciding. No decision was made at this time. The request for radios will be revisited at the October 2, 2024 Commission Meeting.

John Walter - Bodycam Invoice

John Walter presented the Commission with an invoice for bodycams.
