Tentative Schedule for 2024 Taxes

- April 1, 2025** IF 1ST HALF HAS NOT BEEN PAID THEN THE FULL YEAR PAYMENT IS NOW DUE. (You can no longer pay half year. However, not all tickets have to be paid at the same time)
- May 1, 2025** TAXES BECOME DELINQUENT. \$3.00 DELINQUENT FEE HAS BEEN ADDED TO EACH REAL & PERSONAL PROPERTY TAXES, FIRE FEE & AMBULANCE FEE TICKETS.
AMOUNTS DUE ON REMINDER STATEMENTS ARE NO LONGER VALID.
(Your check(s) will be returned if you do not remit the correct amount due)
- May 9, 2025** LAST DAY TO PAY TAXES, FIRE FEES & AMBULANCE FEES BEFORE PUBLICATION. (Payment must be IN Office by 5:00 pm. -- **NO POSTMARK**)
- May 12, 2025** \$17.00 PUBLICATION FEE HAS BEEN ADDED TO REAL & PERSONAL PROPERTY TAXES, FIRE FEES & AMBULANCE FEES. (total fee-now \$20.00 on each Ticket)
- September 3, 2025** \$3.00 ADDITIONAL DELINQUENT FEE HAS BEEN ADDED TO REAL PROPERTY TAX (total fee-now \$23.00 on each Real Property Ticket)
- September 5, 2025** LAST DAY TO PAY BEFORE PUBLICATION (payment must be IN Office by 5:00 pm – **NO POSTMARK**) ***NO PERSONAL OR BUSINESS CHECKS ACCEPTED AFTER THIS DATE***
- September 8, 2025** ADDITIONAL \$32.00 PUBLICATION FEE HAS BEEN ADDED TO EACH REAL PROPERTY TAX TICKET, PLUS \$10.00 PER LIEN HOLDER (total fee – now \$55.00 + lienholders on each Real Property Ticket)
MUST BE CERTIFIED FUNDS (CASHIERS CHECK, MONEY ORDER, CASH OR CREDIT CARD)-PERSONAL & BUSINESS CHECKS WILL BE RETURNED
- October 3, 2025** LAST DAY TO PAY BY CREDIT CARD-IN OFFICE OR ONLINE
- October 31, 2025** LAST DAY TO PAY **MORGAN COUNTY SHERIFF'S TAX OFFICE-** (PAYMENT MUST BE IN OFFICE BY 5:00 PM)
- November 1, 2025** ALL PROPERTIES HAVE BEEN **"CERTIFIED TO THE STATE OF WV"** AND MUST BE REDEEMED THROUGH THE STATE AUDITORS' OFFICE
