# ARC Grant for trail feasibility from Cacapon State Park to the C&O Canal

The initial application for the ARC trail grant was denied. The alternative is to do a 50/50 match for the new grant. The initial for the denied grant that was already approved was \$82,000. The new amount is \$82,368. Commissioner Tuttle made a motion to allow Region 9 to apply for the ARC Grant for the trail from Cacapon State Park to the C&O Canal and

So far, HUD has allocated \$455,810 for the Eastern Panhandle. Morgan County's allocation is currently at \$162,761. Commission Tuttle made a motion to approve the Resolution for Morgan County to participate in the HOME Consortium of the Eastern Panhandle from July 1, 2025 to June 30, 2026. President Clark voted yea, Commissioner Tuttle voted yea and Commissioner Forney voted yea. Motion carried.

### **Estate of Debra Waugh**

Tammy McWilliams and Eric Black informed the Commission that Danny Smith, administrator of the estate, has resigned from the estate and the families have come to an agreement. Jeremy and Jonathan Waugh will be qualifying as the new administrators. This will conclude the matter that was brought before the Commission.
